BOARD MEETING REPORT:

LIVE OAK PARTNERSHIP INC.

During the May meeting of the Board of Directors of the Live Oak Partnership, it was agreed to move forward with the incorporation process. Therefore, Articles of Incorporation, Organizational By-Laws and Board Members and Officers were approved.

A monthly schedule of meetings has also been established. The Board of Directors of the Live Oak Partnership will meet on the fourth Tuesday of each month at 5:30pm, with our next meeting being on Tuesday, August 24.

These meetings are scheduled to be held at Magnetic Marketing, 124 East Howard Street, on the corner of Highway 90 and Dowling Avenue *(West of the Dixie Grill Restaurant)*. Special thanks are extended to Sid Allen and Jeanne d'Eaude' of Magnetic Marketing for allowing us to use their facilities.

REVITALIZATION PLAN PRESENTATION

"A VISION FOR OUR DOWNTOWN"

Our Downtown Revitalization consultant is preparing final notes for a formal presentation to the Live Oak community.

He will present a proposal to the Community Redevelopment Agency (CRA) of the City of Live Oak in a workshop session on Tuesday August 10 at 6:15 pm. This meeting will be open to the public and will be held in the City Council Chambers of City Hall. During this meeting, Mr. Beeler will present specific recommendations that directly relate to the CRA and officials of the City of Live Oak.

The Live Oak Partnership will host an open house to allow Mr. Beeler an opportunity to present the full presentation to the general public, including the business community. This presentation will be complete with PowerPoint slide show, pictures of potential design and streetscapes as well as a plan of action for the completion of desired steps. This presentation will be on Thursday, August 19 at 6:00 pm, at the City Hall Annex complex. Light refreshments will be served.

Please make every effort possible to be in attendance for this presentation. Mr. Beeler will not be telling us what we <u>MUST</u> do, but instead he will be presenting some options and opportunities that we <u>CAN</u> do to improve the physical and economic conditions of our downtown community. FROM THE CHAIR...... WHY SO MANY COMMITTEES ??"

The objective of The Live Oak Partnership is to enhance the physical, economical and social revitalization of historic Live Oak by utilizing Main Street's four point approach. The 4-Point Approach of downtown revi-

talization is a cumulative and incremental strategy that focuses on four key areas of revitalization: Design, Promotion, Economic Restructuring, and Organization. According to downtown revitalization experts, a successful program must focus equally in each of these program areas working in just one or two is not enough. This 4-Point approach is being followed in over 1700 communities across the country and the results have been tremendous.

Therefore, the structure for the standing committees of The Live Oak Partnership follow this basic formula as well. The Organization Committee is the coordinating framework through which the other committees function. It is the liaison between the various committees, and it is the group concerned with Board and volunteer recruitment; fundraising; with promoting the partnership and its programs, coordinating announcements, press releases, the web site and newsletter. The Design Committee works to shape the physical image of downtown to include; facade improvements, sidewalk and storefront design and pedestrian safety. This committee is concerned with everything that makes the downtown an appealing, attractive place for residents, merchants and visitors. The Promotions Committee promotes the downtown as a center for commerce, culture and community. It is responsible for the special events, festivals and contests which have become such a positive defining aspect of downtown. The Economic Restructuring Committee recruits, retains and strengthens businesses in the downtown. Its projects include market analysis, seminars, consulting, developing grants and investment, and promoting innovation to help small business grow. The Arts, and Heritage Committee provides leadership, advice and assistance on the development and implementation of municipal arts and culture and heritage policies, heritage designations, strategies and programs to support heritage events and programming, the preservation and interpretation of monuments, memorials, murals, public art displays, structures and natural and archaeological sites.

In addition to standing committees, The Live Oak Partnership also has in place a structure of sub-committees and project chairpersons. The Publicity Chair leads the organization committee in oversight of promoting the Partnership and its activities. This differs from the responsibilities of the Promotions Committee in that they promote the downtown business district and the commerce of Live Oak. The publicity chair serves as a part of the Promotions team to maintain continuity is all publicity efforts. The Meet the Merchant Program provides the downtown business community the opportunity to have an open house event for the general public and to network with fellow businessmen and women. In an effort to improve communications with business owners, a Block Captain Program has been initiated. This program provides each business owner with a contact person to express concerns and ideas related to the downtown revitalization effort. The block captain program will work hand in hand with the creation of an Ambassador/Volunteer Program. Through this program, Ambassadors will welcome visitors to downtown at times of events and special gatherings, offer details about our downtown community and its businesses. This program will also lead in the enlistment of volunteers to help with the many projects and programs of the Partnership. As with any other organization, its voice is in the numbers and the numbers reflect its members. The Membership Chairman has the responsibility of presenting a membership program and leading in the enlistment of potential members of the Live Oak Partnership. While the Partnership will not be member-driven, it must be member-lead, that is to say that as a member of the business community, your voice is heard and recognized. From our very early discussions with the business community came a resounding sentiment, 'How can we get our downtown business owners to show some pride in their community?' We have established the making of such a process. The Downtown Pride Program will work to establish such incentives. Some of which might include a cleanup day for downtown, formal recognition of efforts, and the promotion of the new city facade grant program. Each of our events have an Event Chairperson, who is responsible for maintaining communication and event planning details with the board and the community. These chairpersons also have the duties to follow through with event plans to ensure its success and continuance.

While it seems there is a lot of committees and programs, the reality of it is relatively simple. There are five basic committees with subcommittees organized under each of them. Specific programs and projects have chairpersons and everyone works with the same end result in mind — *to enhance the physical, economical and social revitalization of historic Live Oak*.

If you would like to become involved in these efforts, your first step is to begin attending our monthly meetings. I hope to see you there.

Plan Implementation Principles

"Downtown is a process as much as a place."

To help better explain the magnitude of the process involved in implementing the aspects of a downtown revitalization plan consider these nine basic principles.

<u>I Make a Great Plan</u>

A great plan is one that combines market based potential with a community vision for the downtown area. A great plan is one that excites, motivates and enlivens the community and private investment to take action. A great plan demonstrates commitment to community.

2 Many, Many Projects

A great plan establishes the framework for many, many projects to move forward. "Projects" are broadly defined and can mean a variety of actions including public and private development programs, marketing, beautification improvements, and community events.

3 Many, Many Stakeholders

Stakeholders form the basis of political support for implementation of the plan. The broadest possible base of stakeholder involvement will promote the plan's implementation. Stakeholders represent a cross section of business, community, civic, non-profit, educational, and government organizations.

4 Committed, Ongoing Leadership

If something is to happen, it has to be someone's job. Leadership to move the plan forward, with support and respect from the community. Leadership to organize and motivate stakeholders and in bringing about partnerships. Leadership in assuming accountability for the plan's implementation.

5 A Good Organization

Support for the plan implementation through an organization that provides communication and coordination. A good organization provides the long-term continuity to see the plan implemented, unifies divergent interests, supports private and public investment activities, monitors progress, and celebrates success.

<u>6 Development Standards</u>

Clear and concise guidelines that communicate the vision. Encourage what is desired and strongly prohibit that which is not wanted. Development standards that are performance based encourage creativity and innovation; and set high quality, achievable objectives.

7 Communications and Marketing

Both the organization and leadership continually market and communicate the success of the implementation. Communicating means acting as a liaison between stakeholders, projects and the community.

8 Supportive Government

Support through policy development, regulations, and code enforcement. Support through technical staff expertise and assistance. Support through championing the plan.

9 Ongoing Review

Dynamic plans require review and adjustments to respond to changing conditions. Monitoring and accountability to measure success.

These nine principles are interactive, rather than sequential. These principles will become priorities of the Live Oak Partnership and its leadership team as a bold strategy is developed during the coming months.

All of these principles relate to responsibilities. The implantation process cannot and should not be completely up to the Partnership board members. We need your help! We all have an investment in our community.
